## “NDA” No Dark Area Helios®

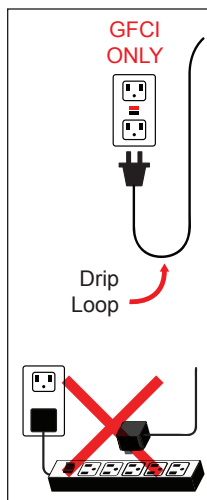
Standard light fixtures that use standard American light bulbs available in the states are not made to illuminate the complete aquarium. In fact, a 24in. bulb is used in a 36in. aquarium kit thus 30% of the aquarium is without light. Helios® HO T5-III Fixtures are custom tailored with Universal Euro size bulbs, meaning it lights your aquarium completely from end to end.

## WARNING AND SAFEGUARD

### WARNING

- » This product may contain chemicals known to the State of California to cause cancer and/or birth defects or other reproductive harm. Wash you hand after handling the product.
- » Hg lamp contains Mercury. Manage in accordance with disposal laws. See: [www.lamprecycle.org](http://www.lamprecycle.org)
- » It is your sole responsibility to verify that the plug and receptacle are clean/free of moisture and salt build up at all times. The receptacle must be free of water, salt, calcium, and magnesium. Failure to do so may cause fire and/or loss of life.
- » Do not plug into an extension cord or power strip.
- » A drip loop must be used when plug into any electrical devices. A drip loop is part of the cord hanging below the receptacle.
- » The national code requires all aquarium equipment to be plugged into a G.F.C.I. (Ground Fault Circuit Interrupter) electrical outlet. If you do not have a G.F.C.I., have an electrician install one prior to operating any aquarium components.

1. Read and follow all instructions.
2. Bulbs can be HOT. Handle with care. Never touch the bulb while operating.
3. Use this product for its intended use only.
4. Do not operate if the plug or wire is damaged. Discard unit.
5. Do not place above an open top aquarium.
6. The light fixture and connections need to be free of water, moisture and salt build-up at all times. Failure to do so will cause electrical arcing resulting in fire and/or electrical shock.
7. The light fixture must be turned off and disconnected from the power supply before weekly maintenance on either the light fixture or the aquarium.



8. Verify that hands are dry prior to disconnecting the power.
9. To reduce the risk of electrocution, keep all connections dry.
10. Never let light fixture come in contact with water.
11. If the light fixture falls or comes into contact with water/excess moisture, unplug the light fixture from the power supply before removing. Failure to do so may cause electrical shock or injury.
12. Never yank or pull the cord from the electrical outlet.

## **DIRECTIONS FOR INSTALLATION**

### **INSTALLATION ON AQUARIUM:**

1. Remove protective plastic from the fixture.
2. The bulb may have shifted through shipping process. Therefore, verify the bulb pins are placed properly in the light bulb sockets.
3. Confirm the silicone water resistant endcaps are installed properly. The endcaps should be completely over the light bulb socket.
4. Place the fixture over the glass top of the aquarium –  
***DO NOT PLACE OVER AN OPEN TOP AQUARIUM.***
5. Plug the unit directly into a G.F.C.I. outlet.

### **INSTALLATION AS RETROFIT KIT:**

1. Remove protective plastic from the fixture.
2. The bulb may have shifted through shipping process. Therefore, verify the bulb pins are placed properly in the light bulb sockets.
3. Confirm the silicone water resistant endcaps are installed properly. The endcaps should completely over the light bulb socket.
4. Verify the length of the screw will not penetrate the thickness of the canopy.
5. Using a Phillip screw driver, installs the mounting clips.
6. Clip the fixture into the mounting clips.
7. Verify the fixture is secure on the canopy -  
***DO NOT PLACE OVER AN OPEN TOP AQUARIUM.***
8. Plug the unit directly into a G.F.C.I. outlet.

### **Replace with genuine Helios® Euro size bulbs**

***NOTE: Bulb must be replaced every 6 months for proper performance.***
